What is an Enrolled Agent?

An Enrolled Agent (EA) is a federally licensed Tax Practitioner who has technical expertise in the field of taxation and is empowered by the U.S. Department of the Treasury to represent taxpayers for audits, collections and appeals before all administrative levels of the Internal Revenue Service. "Enrolled" means to be admitted to practice by the Federal Government and "Agent" means authorized to appear in place of the taxpayer before the IRS. Only enrolled agents, attorneys and certified public accountants may represent taxpayers in all levels of the IRS.

The Enrolled Agent profession dates back to 1884 when Congress acted to regulate persons who represent citizens in their dealings with the U.S. Department of the Treasury.

Unlike attorneys and certified public accountants, who may or may not choose to focus on taxes, all Enrolled Agents (EA) specialize in Taxation
