Phyllis Jo Kubey has been preparing tax returns and offering tax planning and consultation since 1986. In 1985 she enrolled in H & R Block's tax preparation course to learn to better prepare her own income tax returns. She fell in love with the work (and they with hers – they hired her out of the class to work for the company) and worked part-time for Block in January of 1986. This was an amazing opportunity with excellent training and exposure to a lot of different types of tax returns and situations. Also, it was in the days before computerized tax preparation programs – working with pencil, adding machine, and actual tax forms – giving Ms. Kubey the increasingly rare (as younger preparers work with computerized tax preparation right away and trusting the usually accurate, but not always, tax preparation software) experience of actually working out the calculations involved in a complex tax return and knowing where all the information flows on both federal and state returns. Ms. Kubey opened her own tax business later that year and has been in business continuously for 30+ years. She continued to work part-time for H & R Block until 1989 when she left to devote more time to her own business.

Ms. Kubey has earned the professional licenses of Certified Financial Planner (CFP®), Accredited Tax Advisor (ATA), Accredited Tax Preparer (ATP), and Enrolled Agent (EA). She is a fellow of the National Tax Practice Institute (NTPI) and a member of the National Association of Enrolled Agents (NAEA), National Association of Tax Professionals (NATP), National Society of Accountants (NSA), Pride Planners, National Society of Tax Professionals (NSTP), NCPE Fellowship, and Financial Planning Association (FPA).

Ms. Kubey subscribes to numerous comprehensive tax research services and many professional publications to stay current and to have access to the most up-to-date tax information available. She moderated the NYSSEA Tax Questions Google Group, a forum for NYS Enrolled Agents, for several years, and remains an active participant.

To maintain the licenses listed above, Ms. Kubey takes at least 30 continuing educations credits (actual credits = 121 for calendar year 2013/180 for calendar year 2014/192 for 2015/241 for 2016/269 for 2017, and 137 for 2018) each year for tax certification and at least 24 credits each year for financial planning certification.

As an enrolled agent/EA Ms. Kubey is admitted to practice before the IRS and most state taxing authorities and enjoys the same practice privileges as CPA's and Attorneys.

EAs are the only tax preparers licensed in all 50 states by the U.S. Treasury Department who not only prepare returns, but can represent taxpayers before all administrative levels of the IRS. They run interference between you and the IRS and state taxing authorities to insure that you get fair treatment.

She specializes in IRS and state tax-related representation – audits, collection, non-filing cases, etc. – and has particular expertise in areas relating to musicians, actors, artists, non-resident alien tax issues, US citizens working abroad, same-sex couples, and clergy.

Ms. Kubey is active with NYSSEA (New York State Society of Enrolled Agents), having served two terms as a Director of the NYSSEA, and now serves as NYSSEA's second vice president. She was featured in the Member Spotlight of the June 2013 issue of National Society of Accountant's magazine, Main Street Practitioner. Ms. Kubey was appointed, in January 2017, to serve on the IRSAC (Internal Revenue Service Advisory Council). The IRSAC, a panel of tax experts appointed from all over the United States, advises the IRS on policy, procedure, programs, and initiatives. She chaired the IRSAC's SBSE/W&I (Small Business/Self-employed and Wage & Investment) subgroup in 2018 and chairs the Wage & Investment subgroup (as the IRSAC absorbed two other advisory councils and split SBSE and W & I into separate subgroups) in 2019.
